AMENDMENT TO AGREEMENT

This Amendment to Agreement (this "Amendment") is made as of the date last set forth on the signature page hereto ("Amendment Effective Date") by and between UpToDate, Inc., with its principle business location at 230 3rd Avenue, Waltham, MA 02451 ("UpToDate"), and Agenzia Italiana del Farmaco AIFA, with its principle business location at Via del Tritone, 181, Rome, 00187, Italy, (the "Customer," and together with UpToDate, the "Parties").

RECITALS

A. UpToDate and Customer are parties to that certain Agreement dated February 26, 2018, Contract No. 001-00-48443198, (the "Agreement"), pursuant to which Customer has subscribed for the *UpToDate Anywhere* license.

B. UpToDate and Customer wish to amend the Agreement to extend the term of the Agreement in exchange for Customer's payment of the Subscription Fees (as defined below) as set forth in this Amendment.

1. **Subscription Fees**. Customer shall pay to UpToDate the additional Subscription Fee of \$6,500.00 USD (plus tax where applicable) for the extension of the term of the Agreement (the "Term") by one year, in accordance with the terms applicable to fees set forth in the Agreement. The payment of the additional subscription Fee shall be paid within thirty (30) days of the Amendment Effective Date.

2. **Term**. The Term is hereby extended for one year, beginning March 1, 2019 and ending February 29, 2020.

3. **Confirmation of Your Information**. The statistics on which UpToDate based the additional Subscription Fee for the extension of the Term are as follows:
