If any provision of this agreement is found to be invalid, illegal or unenforceable, such provision will be severed from the Licence and the other provisions shall remain in full force and effect.

The Contract shall be governed by and construed in accordance with French Law and shall be subject to the exclusive jurisdiction of the courts of Paris.
